Bids shall be valid for a period of sixty (60) days after Bid opening and must be accompanied by security of 2% of Estimated Amount and shall be delivered to Director (P&D) WASA Faisalabad, Main Office on or before 12:30 PM, April 18th, 2018. The same will be opened after 30 minutes of the closing time in the presence of the bidders who wish to attend
- 5. All bidders shall be required to submit with their bids, qualification information specified in the bidding documents. Pre-Bid meeting will be held on 14-04-2018 at 11:00 Hours in Committee Room WASA Main Office Jail Road Faisalabad. In the presence of the bidder who wish to attend. .
- 6. Bidders are required to be submitted on *item rate basis* (not on the basis of Composite Schedule of Rates with percentage premium) and the rates and amounts (in Rupees) must be filled by the bidder in figure as well as in words for each item in the Bill of Quantities (Bid Schedule) and provide a total price. Non-compliance may result in rejection of bid.
- 7. Bidders should give their best and final price in their bids as no negotiations are expected.
- 8. As provided in the bidding documents, bidders engaged in corrupt or fraudulent practices (including collusion/pooling) will be declared ineligible, either in indefinitely or for a stated period of time, to be awarded a contract financed by the World Bank.

- 9. The bidder shall specify the name of product, country of origin, manufacturer along with Authority Letter, he wants to offer.
- 10. The bidder shall provide brochure of the offered product and its application manual.
- 11. The bidder shall include all taxes and duties in the bid price.
