
TERMS & CONDITIONS:

2. Sealed tenders will be received and opened in PMU Office Samundri Road Faisalabad on 02/08/2017. Bids receiving time is 12:00 P.M & Opening time is 12:30 P.M.
3. Only duly authorized representative of the contracting firms can purchase / receive tender documents on showing of Valid P.E.C License, Renewal of Firm & National Identity Card in Original.
4. Affidavit on 100 Rupees Judicial Paper that the firm has not been blacklisted.
5. Earnest money must be accompanied with the tender which should be valid for at least Sixty (60) Calendar days from the date specified for opening of the bids otherwise the same will not be entertained. Conditional tenders will not be entertained.
6. Tenders shall be opened in the presence of interested bidders or their representatives who may care to be present.
