TERMS & CONDITIONS:

1. Tender documents can be obtained from the office of Deputy Director (P&D), WASA immediately i.e. date of publishing in newspaper & also uploading on PPRA website upto 24/03/2017 during working hours on depositing requisite tender fee in WASA Account.
2. Sealed tenders will be received and opened in Committee Room WASA Main Office Jail Road Faisalabad on 25/03/2017. Bids receiving time is 12:30 P.M & Opening time is 01:00 P.M.
3. Affidavit on 100 Rupees Judicial Paper that the firm has not been blacklisted.
4. Only manufacturer authorized representative firms/dealers can obtain /purchase bidding/tender document on showing authorization letter of the manufacturing firm.
5. Earnest money must be accompanied with the tender which should be valid for at least Sixty (60) Calendar days from the date specified for opening of the bids otherwise the same will not be entertained. Conditional tenders will not be entertained.
6. Tenders shall be opened in the presence of interested bidders or their representatives who may care to be present.
7. Procedure of open competitive bidding i.e. Single Stage Two Envelope System shall be adopted.
8. If clarification and amendment in the bid is needed before the date of bidding, addendum to this effect can be issued even one day (24-hours) before the tender opening date / time.
9. If any further information is required regarding the tenders, please visit the office of the undersigned during working hours prior to date of opening.

SPECIAL CONDITIONS:

1. The bidder shall specify the name of manufacturer, country/origin and model which he wants to offer.
2. The bidder shall provide brochure of the offered product and its application manual.
3. The bidder shall include all taxes and duties in the bid price.
4. The bidder should submit the bid in two parts, the first part shall be for specification, called the **"technical bid"**, the second one for cost called the **"financial bid"**. These bids should be in sealed envelopes and be submitted separately.

5. Successful bidder is bound to arrange third party inspection at factory prior to shipment which will nominate by department.
6. Successful bidder has to provide orderbook to department, gate pass, delivery invoice, shipment documents, custom duties, clearance documents at the time of delivery.
7. The technical bid will be opened first and evaluated. If the specifications of the bid meet the requirement of bid document, the bid will be qualified for opening of financial bid, otherwise the same shall be returned unopened.
