2. Sealed tenders will be received and opened in Committee Room WASA Main Office Jail Road Faisalabad on 24-03-2017. Bids receiving time is 11:30 A.M & Opening time is 12:00 P.M.
3. Only duly authorized representative of the contracting firms can purchase / receive tender documents on showing of Valid P.E.C License, Renewal of Firm & National Identity Card in Original
4. Affidavit on 100 Rupees Judicial Paper that the firm has not been blacklisted.
5. Earnest money must be accompanied with the tender which should be valid for at least Sixty (60) Calendar days from the date specified for opening of the bids otherwise the same will not be entertained. Conditional tenders will not be entertained.
6. Tenders shall be opened in the presence of interested bidders or their representatives who may care to be present.
7. Procedure of open competitive bidding i.e. Single Stage Two Envelope System shall be adopted.
8. If clarification and amendment in the bid is needed before the date of bidding, addendum to this effect can be issued even one day (24-hours) before the tender opening date / time.
9. If any further information is required regarding the tenders, please visit the office of the undersigned during working hours prior to date of opening.
10. The bidder shall specify the name of product, country of origin, manufacturer he wants to offer.
11. The bidder shall provide brochure of the offered product and its application manual.
12. The bidder shall include all taxes and duties in the bid price.

13. The bidder should submit the bid in two parts, the first part shall be for specification, called the "technical bid", the second one for cost called the "financial bid". These bids should be in sealed envelopes and be submitted separately.
14. The technical bid will be opened first and evaluated. If the specifications of the bid meet the requirement of bid document, the bid will be qualified for opening of financial bid, otherwise the same shall be returned unopened.
