- Sealed tenders will be received and opened in the presence of Tender Opening Committee, in Committee Room, WASA Main Office Jail Road Faisalabad on 16-02-2019 in the presence of interested bidders of their representatives. Bids receiving time will 12:00 P.M & Opening time is 12:30 P.M.
- 3. Authorized representative of the contracting firms can purchase/receive tender documents on provision of original authority letter.
- 4. Earnest money must be accomplished with the tender which should be valid for at least Ninety (90) calendar days after the date specified for opening of the bids otherwise it will not be entertained.
- 5. Procedure of open competitive bidding = Single Stage two Envelope System.
- 6. The bidders shall submit the bid in two parts. The first part shall be for specification, called the "Technical Bid", the second one for the cost, called the "Financial Bid". These bids should be sealed and submitted in two separate envelopes.
- 7. The technical bid will be opened first and evaluated. If the specification of Technical bid meet the requirement, then bid will be qualified for opening Financial Bid, otherwise the same shall be returned unopened.
- 8. The bidder shall include all taxes and duties in the bid price and payment will be made in PKR.
- 9. The whole process of bidding shall be governed by the PPRA Rules.
- 10. All the bidding documents shall be uploaded on the PPRA website as well as WASA website.
- 11. No Judicial proceedings could be initiated against decision of the committee and the decision of the committee shall be final
