TENDER NOTICE FOR SUPPLY OF CHLORINE GAS FOR WATER RESOURCES DIRECTORATE AND FRENCH FUNDED PROJECT NOVELTY PULL, WASA, FAISALABAD.

- Water and Sanitation Agency (WASA), Faisalabad Development Authority (FDA) (herein after referred to as the "Client") intends to Purchase of Chlorine Gas 99.9 % for Disinfection of water distribution network through framework contract for one year (extendable) under Punjab Procurement Rules 2014.
- 2. Sealed bids are re-invited from the Manufacturers of Chemicals / Importer / Authorized Dealers / Contractors, duly registered with FBR and PRA (having NTN, STRN and PNTN) for the Purchase of Chlorine Gas 99.9 % through framework contract basis for one year (extendable). The supply of gas will be as per requirement at WASA Main Office Opposite Allied Hospital, Faisalabad.
- Bidding Documents, containing detailed terms and conditions are available immediately
 after publication at the office of Director Planning and Design, Main office WASA, opposite
 Allied Hospital, Faisalabad and a complete set of bidding documents can be obtained on
 of Pak Rs. 1000 (Pak Rupees One Thousand Only).
- 4. The bids prepared in accordance with the instructions given in the bidding documents must be accompanied by a Bid Security 2% of estimated cost in the shape of CDR. Last date for purchase of bidding documents is 21st July 2020. The bids must be delivered at the address given above on 23rd July, 2020 at 11:00 A.M. The bids will be opened on the same day at 11:30 A.M in presence of the bidders / bidder's representatives who choose to participate.
- The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal Under Punjab PPRA Rules 2014 (Rule-35).
- Procedure of open competitive bidding i.e Single Stage Two Envelope System shall be adopted.
- 7. The bidder should submit the bid in two parts, the first part shall be for specification, called the "technical bid", the second one for cost called the "financial bid". These bids should be in sealed envelopes and be submitted separately.
- 8. The technical bid will be opened first and evaluated. If the specifications of the bid meet the requirement of bid document, the bid will be qualified for opening of financial bid, otherwise the same shall be returned unopened.

The bidders shall specify the name of manufacturer / registered supplier and specification he wants to offer along with the authorization by manufacturer / registered supplier.

- 10. The bidder shall include all taxes and duties in the bid price.
- 11. Procurements shall be governed under the Punjab Procurement Rules 2014.
- 12. Conditional tender will not be accepted.
- 13. No tender will be accepted which is received telegraphically or by post.
- 14. No tender will be issued on the date of receipt of tender.
- 15. Tendered rates and amount should be filled in figures as well as in words and tenders should be signed as per general directions given in the tender documents.
- 16. In case the total tendered amount is less than 5% (five) of the approved estimated (DNIT) amount, the lowest bidder will have to deposit additional performance security from the Scheduled Bank.
- 17. The bids will be valid for 120 days.
- 18. Estimated cost Rs. 6.149 Million.
